- Weather policy there are no guidelines set currently. Anything -5 degree flat temp and under with a -15 windchill is an optional practice for kids. Rinks to close at -10 degrees. Heated benches, toe/hand warmers available.
- Tournament games coach discretion unless temps negative 30 windchill.
- Twig Days Rinks will need to be ready. M1s have pancake breakfast. M2s concessions. Squirts Dance.
- Banquet date, election details and anticipated BINGO days to be scheduled during next meeting.
