7. Concession Report: Amanda Radzak and Heather Korpela

- End of March 2017 balances: Checking \$6,585.39 and Savings \$1,001.62
- Concession opened on December 15th, 2016-February 17th, 2017.
 Concession was open 38 days and closed 27 days. Concession made \$8,176.50 during the days that it was open.

8. Old Business:

- 2016-2017 year in review:
 - o Dec. 5th making ice making began.
 - o The rinks opened on Dec.15th.
 - o The rinks closed on Feb. 17th, 11 days sooner than last year.
 - o The rinks closed 4 days due to cold weather.
 - o The rinks closed 10 days due to warm weather.
 - o TAHA had a 62 days season. The rinks were open for 48 days, same as last year.
 - Twig hosted 2 tournaments with 20 teams and 225 players from other associations.
 - Twig hosted 6 league games and multiple scrimmages.
 - Twig had 14 teams with 140 players at our Twig Days event of Feb.
 - o The rinks were graded and leveled in October, made for much easier ice making.
 - o A new walk behind floor cleaner was purchased for the warming shack and community center.
 - o Logged in over 2,000 hours of volunteer hours.

9. New Business:

- Rink update by Dan Stauber: 292 Group is designing it. Johnson Wilson is the contractor on the project. The initial design was rather large, so they will be scaling it back and proposing a new design. Construction is slated to start in mid to late June. The arena is will most likely be done by March 2018. Key components: community center, walking track on the 2nd level, locker rooms (8-10).
