#### **Bravden Ward** - Personnel

- Notes:
  - Registration numbers: 14 M1's; 14 M2's' 14 Squirts; 2 Mirage.
  - Anticipating 2 M1 teams; 2 M2 teams; 1 Squirts team
  - 2 new M1 coaches possible.

#### **Dan Johnson - Facilities**

- Notes:
  - M2 have 2 teams registered in all tournaments, except Silver Bay.
  - M2 league schedule is complete however Voyageur league only has 1 team registered. Likely, games will be alternated between the two teams.
  - M1 and M2 practices to be held at the same time on different rinks (Tue and Thursday at 6pm). Squirts practices to be held at 7pm.
  - Rink doors need fixing.
  - Possible new Zamboni found, working on the details. May need transportation and would consider advertising the logo of a company if a sponsor to assist with transporting is found.
  - District 11 meeting was attended by Dan.
    - The district will be cracking down on fan behavior including consequences and fines for fans if kicked out.
